

Check List for Lottery Returns

Please use this checklist to ensure the 'Return' has been completed correctly

- All boxes on the form have been completed
- The draw(s) took place **AFTER** the tickets/chances were sold
- The expenses and prizes (not including donated prizes) do not amount to more than 80% of the total proceeds
- At least 20% of the total proceeds are allocated for the purpose(s) of the society. The purpose(s) are those given on the registration application form e.g. to raise money for the roof of St Mary's Church.
- The amount given in the total proceeds box, minus the amounts in the expenses and prizes boxes is allocated to the purposes of the society (whether actually spent at the time of submission of the 'Return').
- The arithmetic is correct - Box A minus Boxes B and C equals Box(es) D
- All donated prizes (if any) have been declared. You can for example list as 6 bottles of red wine; 9 bottles of white wine; 12 boxes of chocolates. Only if an individual prize is worth £100 or more does the value have to be declared e.g. a balloon ride worth £120. Several small amounts of cash can be amalgamated; however it is recommended that the society keep a record of each amount from each donor.
- If no prizes have been donated please write " No prizes donated" in this table
- It has been returned to the Licensing Service within 3 months of the last draw in the lottery taking place. **Please note that this is a legal requirement; not to do so is an offence**
- It has been signed by the promoter (the individual who has responsibility for the draw(s) who is 18 years or over.
- The society has notified the Licensing Service of any changes of promoter
- It has been signed by the **two** persons 18 years or over who were appointed in writing by the society to certify lottery returns.
- A copy of those appointments are enclosed with the lottery return. **Please note that this is a legal requirement.**
- I understand that if the above information is not provided, the 'Return' will be sent back to me
- I understand that an email address should be provided to enable communication

This statement must be submitted **no later than three months** beginning on the day on which the draw (or last draw) in the lottery took place. It must be signed by the promoter, and two members of the Society appointed in writing for that purpose by the Society, or its governing body if applicable, **and** accompanied by a copy of that appointment. All signatories must be over the age of 18 years.
